**Due with Registration Form: Non-Refundable Registration Fee (\$100), Morning School Supply Fee (\$180), and Afterschool Care Supply Fee (\$45) per child**

School tuition, along with before care, and after care tuitions are paid in ten (10) equal installments due on the first day of each month, with the first payment due on August 1<sup>st</sup> and the last due on May 1<sup>st</sup>. All fees not paid by the 8<sup>th</sup> of each month incur a late payment fee.

Good Shepherd must have a Food Allergy Emergency Plan, prepared by the child's health care professional on file if your child has been diagnosed with a food allergy. This plan must include the food your child is allergic to, possible symptoms if exposed to the food, and the steps to take if an allergic reaction occurs. A parent, or legal guardian, and the health care professional must sign this form. Your health care professional can supply this form.

Good Shepherd Episcopal School Immunization Policy: All families must provide an up-to-date immunization record for their child, stamped by the doctor's office or clinic, as defined by the Texas Department of Health and Human Services (Child Care Licensing). Any exceptions must be taken to the Good Shepherd School Board for a decision.
